




# Holland Rule - A View From The Source: Tim Holland

The controversy over the Holland Rule continues and before the rule gets "dumped" by majority vote, it is important to provide the history of the rule. The Holland and the Crawford Rules were introduced some 20 years ago and most active players today have no idea why the rules were created. HBC was able to contact Tim Holland and in a telephone conversation on March 13th, he explained his reasons for the inception of the Holland and Crawford Rules.

Tim Holland played backgammon before there was a Crawford or a Holland Rule. He saw a disadvantage for a leader in a match as the leader approached match score. The trailing player had no restrictions on the use of the cube and could double at any time, including his first move in a game. The trailing player would double because of score only and not because of the philosophy of the cube in tournament play which is doubling because of position and score. To remedy this, the rule now known as the Crawford Rule was introduced first. Tim noted that he originated the rule but Mr. Crawford implemented the rule therefore it was named the Crawford Rule. Even after the Crawford Rule was in effect, Tim continued to see a disadvantage for the leader after the Crawford Game. The trailer could still use the cube to his advantage after the Crawford Game; doubling again because of score only. The Holland Rule was introduced to remedy this situation. By having at least 2 moves on both sides, the decision to take or drop is based on "some" position and score and not just score. Tim pointed out that without these rules, the trailer could double without restriction therefore increasing the luck factor in the game. Tim saw backgammon without these rules as a negative aspect to an otherwise beautiful game. Tim still believes in both rules today as he did when the rules were introduced 20 years ago.



## Editorial-Holland Rule

The introduction of the doubling cube to backgammon has been hailed as the single most element that makes backgammon what it is today. The addition of the Holland Rule as well as the Crawford Rule increases the value of the cube by keeping intact the philosophy of the cube. The Crawford Rule seems to be firmly established and currently the Holland Rule is not. The Holland Rule should be added to the U.S. Backgammon Tournament Rules and Procedures, at minimum, as a option. We, the players, control how much luck and skill there is in backgammon by the rules we abide by.


## Bill Robertie vs Ray Glaeser


33 Point QuarterFinal Match


This year the **HBC Newsletter** presents one of the quarter final matches from the first World Cup between twice world champion Bill Robertie and Ray Glaeser. World Cup II will be held in Boston, August 7-12. Qualifiers for World Cup II will be held across the country, including Michigan Summer Championships (June 29-July 1).


Instructions: You will need a backgammon board to follow along. The board is numbered 1 to 24 with all points numbered based on the view of the player on roll. The home portion of the board is numbered 1-6. Bearing off is denoted as moving to the 0 'zero' point. Each player will always be moving from a higher to lower point with only the point(s) moved to used. To make it easier to follow, the larger number rolled is denoted first. In some situations where the smaller number rolled is forced, it will be presented first. An example: being on the BAR with a roll of 52 with the 5-point made and the 2-point open.

Abbreviations used are CB - Closed Board, EF - Entry Failure, NP - No Play Possible, x - opponents piece was hit,  $5^2$  - superscribe denotes 2 or more pieces moving to the same point; this example has 2 pieces moving to the 5 point. In the doubling positions, Bill is the dark checkers and Ray the light and the board is shown from Bill Robertie's side. Study those first before going through the games.
